Entry Rules & Regulations Vendor Booths Food, Novelties, Games, Crafts, etc. NON REFUNDABLE ENTRY FEES:

\$250 Food/Craft, \$500 Commercial/Marketing Booth

- 1. There will be only one (2) food booth of its kind. If you would like to sell an extra food item it will be an additional \$50 charge.
- 2. Booths and/or spaces 10 X 10 in size or Food truck parameter.
- 3. Booth will be assigned on a first come, first serve basis. ONLY full payment and completed entry form guarantees a booth.
- 4. Anyone selling an item without properly registering the item will be shut down.
- 5. Set up time for a vendor is Saturday, July 3, 2021 at 12:00pm 5pm. We are not responsible for any lost of stolen items.
- **6.** Each vendor will receive ONLY one (1) parking permit. If permits are lost, full admission will be charges. **No overnight parking or camping will be allowed on ground**
- 7. Vendors must provide their own tables, chairs, extension cords (150), additional lighting, or any other necessary items.
- 8. Vendors must take all necessary safety precautions. For example, the proper handling of charcoal, lighter fluid and control of open flames. NOTE: <u>Fire extinguishers (2.5 to 5lb. ABC) ARE REQUIRED</u> at all vendor booths using cooking equipment (open fires, frying, ect.). Failure to abide all safety rules will result in immediate removal from Texas Cook'em grounds.
- 9. Vendors MUST obtain food inspection permit IN ADVANCE from the City of Edinburg, 415 W. University Dr., Edinburg, (956)388-8203, YES ALL FOOD VENDORS.
- 10. A liability form must be signed for each vendor/worker.
- 11. ALCOHOLIC BEVERAGES, WATER, SOFT DRINKS OR ANY OTHER BEVERAGES CANNOT BE SOLD.
- 12. Vendors are encouraged to decorate their booths in 4^{th} July theme: prizes will be awardees for $1st 3^{rd}$ place winners.
- 13. A Mandatory meeting will be held June 28, 2021 at 5:30pm at the Edinburg Chamber of Commerce office.
- 14. The Texas Cook'em committee reserves the right to refuse any vendor application for any reason at its own discretion
