*Note: \$100 Separate Fully Refundable Deposit Required (Cleaning/Damages)*

1. There will be only **two** food booths of its kind. **No vehicles will be allowed on to vendor sites.**
2. **Vendor shall not sell the following items: Burgers, Fries, Hot Dogs, Nachos and Beverages (Beer, Sodas, water and Gatorade).**
3. Booths are 10 X 10 in size.
4. Spaces will be assigned on a first come, first serve basis. **ONLY full payment and completed entry form guarantees a space.**
5. Anyone selling more than one item without properly registering the item will be charged an additional fee or will be shut down.
6. Set up time for vendors must be completed Friday, March 3, 2023 from 12:00 noon to 4:00 pm **(ONLY) NO EXCEPTIONS!**
7. Each vendor will receive ONLY (4) admission Passes. If pass is lost, full admission will be charged. **YOU ARE TO PARK IN THE GENERAL PARKING LOT ONCE YOU UNLOAD. NO overnight parking or camping allowed on grounds.**
8. **You must provide your own tables, chairs, extension cords (150 ft.) or any other necessary items.**
9. Vendors must take all necessary safety precautions. For example, the proper handling of charcoal, lighter fluid and control of open flames. NOTE: Fire extinguishers (2.5 to 5lb. ABC) **ARE REQUIRED** at all vendors using cooking equipment (open fires, frying, etc.). Failure to abide all safety rules will result in immediate removal from Fiesta grounds.
10. **Vendors MUST obtain a food inspection permit IN ADVANCE from the City of Edinburg Health Division, 415 W. University Dr. (956) 388-8203(Speak to Ramon Vela Jr.).**
11. The Chamber of Commerce **IS NOT** responsible for stolen or lost items. There **WILL NOT** be any overnight security provided.
12. A liability form **MUST** be signed for each vendor/worker.
13. **ALL ENTRY FEES ARE NON-REFUNDABLE.** This includes acts of God such as weather.
14. We have the right to refuse any vendor application for any reason at our own discretion.
